## VACANCY ANNOUNCEMENT

### CALL FOR EXPRESSION OF INTEREST/APPLICATION FOR APPOINTMENT AS JUDGE OF THE HIGH COURT OF RIVERS STATE

Pursuant to Rule 3 of the 2014 Revised Guidelines for the Appointment of Judicial Officers of All Superior Courts of Record in Nigeria, and following the announcement of vacancies in the office of Judge of the High Court of Rivers State Judiciary, the Judicial Service Commission, by this notice, hereby calls for expression of interest/application from suitably qualified candidates for appointment as Judge of the High Court of Rivers State.

### REQUIREMENTS/COMPETENCIES

To be eligible for consideration for this appointment, the candidate must satisfy the following minimum requirements:-

- i) Candidate must be a Legal Practitioner in Nigeria and must have been so qualified for a period of not less than ten (10) years with considerable knowledge and experience in the practice of Law.
- ii) Candidate must be of good character and reputation with strong traits of diligence, hardwork, honesty, integrity, sound knowledge of law and consistent adherence to professional ethics;

iii) Candidate must have:

- a) Active successful practice at the Bar, including satisfactory presentation of cases in court as a Legal Practitioner either in private practice or as a Legal Officer in any Public Service; and/or
- b) Satisfactory and consistent display of sound and mature judgment in the office as a Chief Registrar or Chief Magistrate; and/or
- c) Credible record of teaching law, legal research in a reputable University and publication of legal works.
